

- 1.) I acknowledge and agree that I understand the nature of the Cardboard Boat Regatta Event, and related activities and that I am qualified in good health, and proper physical condition to participate in such activity. I further agree that I have no medical or physical condition that could interfere with my safety while participating in this activity, or else I am willing to assume and bear the costs of all risks that may result, indirectly or directly, by any such condition.
- 2.) There is significant risk of injury from the activity, including potential paralysis and death. I, for myself and on behalf of my heirs, personal representatives, and next of kin, release and hold harmless Grand Rapids Chamber of Commerce, representatives, and/or volunteers.
